- 4. Submitted bids must have at least one line-item price for each applicable category (i.e., 1.00 General Conditions; 2.00 Demolition; 7.00 Roofing; 32.00 HVAC; etc.)
- 5. If all bids received by the above deadline are above the SBH determined maximum price, a verbal or written notice of revision will be issued to all bidding general contractors. SBH will then work with the bidders to identify areas to reduce scope and/or identify areas within their bids that are excessively out of line with other received bids. All bids are held in confidence until after the contract is awarded

1.00 General Requirements

Bidder handles all insurance, permits, dumpsters.

Temp heat – contractor handles any temporary heating equipment required during construction. SBH will supply up to 1500KWH elec. per month as defined by the AEP billing cycle for this address. The contractor handles electrical utility costs for added electrical use. Temporary lighting is by the contractor.

2.00 Existing Conditions

Demolition; General

1. Carry out all demolition work in a neat and orderly manner. Keep noise, dust, and similar nuisances to a minimum. Do not collapse walls. Do not throw or drop materials. All demolition must follow guidelines for lead safe work practices.

7.00 Thermal and Moisture Protection

ROOF REPLACEMENT SPECIFICATIONS

MAIN COMPOSITION SHINGLE ROOF:

Complete tear off and removal of (approx. xxxx square feet) of existing shingles, to the surface and properly dispose of at approved landfill.

Replacement of any damaged plywood decking at \$xx per sheet. All misc. work, at an additional cost of materials and \$xx.00/hr. if needed. Decking will be replaced in accordance with recommendations by both the National Roofing Contractors Association (NRCA) and the American Plywood Association (APA). New decking shall be APA-rated for structural use. Deck fastening will meet or exceed local building code requirements.

- Replacement of following flashing materials: Chimney flashing, vent pipe collars, aluminum akes and leaves. All materials to meet or exceed manufacturer's requirements and to be installed "hidden nail" fashion so that no "shiners/nails" are present.
- One row of Ice and Water Protection membrane shall be installed along all leaves, valleys, chimney and around any penetrations and around any penetration to provide protection against damage from water and ice dams.
- Installation of one layer of 30 lb. felt of Palisade synthetic roofing underlayment on entire roof deck surface.
- Installation of new GAF Timberline (or equivalent) HD Lifetime laminated, premium architectural shingles, with Ltd. Lifetime warranty, of homeowner's color choice. Shingles will be installed in strict accordance with the manufacturer's specifications and shall be fastened using four nails per shingle.
- Installation of a Ridge Vent.
- Installation of manufacturer's pre-made hip and ridge material (Caps). Hip and ridge rows will be run straight and shall be installed according to manufacturer's instructions.
- All grounds to be cleaned up on a daily basis. All bushes, shrubs, and flowers will be protected.
- All gutters will be cleaned of all existing and new debris. Otherwise, gutters & downspouts are to be replaced.
- Homeowner is asked to supply electrical power if needed.

All material is guaranteed to be as specified. All work is to be completed in a workmanlike manner according to standard practices. Any alteration or deviation from the above specifications involving extra costs will be charged accordingly.

GUARANTEE: One (1) year roof leak repair under normal weather conditions, excluding hail and wind, from completion date. The warranty shall protect the owner from roof leakage for a period of one year, beginning from the date of completion of the project. The warranty shall cover roof leakage directly attributed to the contractor's workmanship. *Shingles will be covered under manufacturers limited lifetime warranty.

23.00 - HVAC

Demo and remove of Existing,

- c. Provide filter slot with sliding closure panel. Filter to be standard 1" type and sized for airflow. Provide filter. A/C unit shall meet SEER2 of 14 min.

23.00 - WATER HEATER

Replacement,

- a. Acceptable water heater manufacturers are Bradford White; State; Rheem.
- b. Energy factor to be >=0.64.
- c. Water heater insulation blanket is not required. Water heater installation must have

Requirements for Certificates of Insurance
